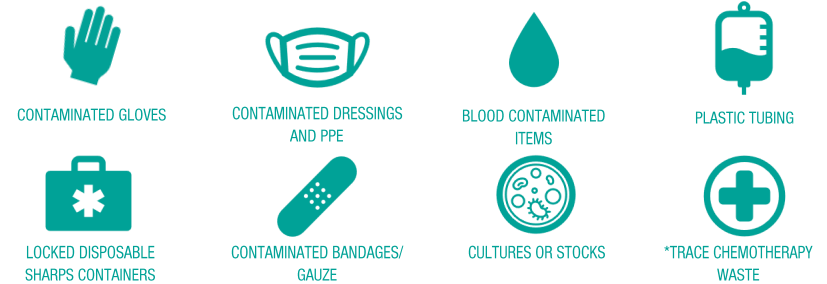

## REQUIRED PACKAGING INSTRUCTIONS:

- DO NOT MARK OR WRITE ON THE CONTAINERS. CONTAINERS REMAIN PROPERTY OF BIO-MED.
- USE PROVIDED BAGS. MEDICAL WASTE MUST BE PACKED INTO RED PLASTIC BAGS LINING THE MEDICAL WASTE CONTAINER FOR DISPOSAL. NO UNCONTAINED LIQUIDS GREATER THAN 20CC PERMITTED.
- SECURE THE LINING BAG BY TYING A "BALLOON" STYLE KNOT TO ENSURE CONTAINMENT OF THE MEDICAL WASTE.
- LID MUST BE SECURED CLOSED WITHOUT OBSTRUCTIONS OR FOREIGN MATERIAL PROTRUDING FROM THE CONTAINER. IMPROPERLY PACKED CONTAINERS WILL BE REJECTED FOR REPACKING (LEAKING, OVERFLOWING, LOOSE SHARPS, ETC).

CONTAINER MUST NOT EXCEED 45LBS. OVERWEIGHT, DAMAGED, LEAKING, OR INCORRECTLY PACKED CONTAINERS MAY BE DENIED PICK UP OR RESULT IN ADDITIONAL FEES. FOR MORE INFORMATION, CONTACT BIO-MED AT: 800.736.2466 OR SALES@GETBIOMED.COM.
